During the year under report, Company has allotted 1,80,000 Fully Paid Equity Shares to the Governor of Maharashtra against funds of Rs.1,00,00,000/- (Rupees one crore) from the Governor of Maharashtra vide Government Resolution No. Sankima - 2016/Pra.Kra.92/Tex-2 dated 06.08.2016 and Rs.80,00,000/- (Rupees Eighty Lakhs) from the Governor of Maharashtra vide Government Resolution No. Sankima - 2016 / Pra.Kra.92/Tex-2 dated 20.12.2018 for further Equity Capital of the Company. There was no change in the shareholding pattern of the Corporation.

The Corporation has not bought back any of its securities during the year under review. The Corporation has not issued any Sweat Equity Shares during the year under review. No Bonus Shares were issued during the year under review. The Corporation has not provided any Stock Option Scheme to the employees.




OPERATIONS :-

The Turnover during 2017-18 amounted to Rs.809.94 lakhs as against corresponding figure of Rs. 350.73 lakhs during 2016-17. The Net loss for the year after provisions for tax was Rs.84.19 lakhs (Previous Year Rs. 315.92 lakhs). The total accumulated loss as on 31.03.2018 stood at Rs.1738.45 lakhs (Previous Year Rs. 1654.25 lakhs). In spite of discontinuation of the procedure of purchasing on the basis of Rate Contract by state undertakings, which was introduced two years back, the turnover of your company showed increase. Your Corporation, on account of Increase in the turnover income during the year, could able to save on the finance cost by reduction in the borrowings particularly overdraft facility. Further during the year Company received funds by way of equity from the Government to the tune of Rs. 100.00 lakhs.


